V. OLD BUSINESS

A. Snow Shoveling Program

Chair Son said she would email the final flyer to Commissioners for distribution.

Chair Son said that the Commission needs to finalize the flyer. Commissioner Moore said the “arrow” and “apply now” should be in red to better stand out on the Snow Shoveling Program flyer.

Commissioner Neill suggested that the words in red on the flyer be “student arrow to senior” or “Students helping Senior Citizens”.

Commissioner Son – shovel snow and make money. How do we want to get the information out to the students?

Commissioner Smith said that Prospect High School has video announcements.

Commissioner Georg said that Rolling Meadows High School has announcements through PA system.

Commissioner Neill stated that Hersey High School has a Service Over Self Club and he can give them the information to share with students.

Commissioner Son will email the final flyer to the Commissioners for Distribution.

Commissioner Neil will get the information to the ARC and Commissioner Healy.

B. Teen Health Programming

Commissioner Moore suggested that Ms. Espinoza should have flyers to distribute. She could then hear their concerns and advise them. The flyers would have her contact information so teens can reach out to her.

Commissioner Georg – Information could possibly be shared as a public PR push. Information about all social workers through the schools could be available on a Social Services table.

Chair Son said it appears everyone is in agreement to try a Social Services Resource Hour at the Library. She said she will reach out to Ms. Espinoza.
