SUBJECT: Liquor License Interview: Brinker Restaurant Corporation dba Chili's Grill & Bar

At the Committee-of-the-Whole meeting on December 2, 2019 representatives of Brinker Restaurant Corporation dba Chili's Grill & Bar will be interviewed for consideration of a Class "AA" liquor license.

Liquor Classification:	Class "AA" license authorizes the retail sale, in restaurants and brew pubs of alcoholic liquor for consumption on the premise where sold. The establishment must have a seating capacity at tables for a minimum of 75 persons.
Establishment Liquor Hours:	Mon - Thurs: 11am – 10pm; Fri - Sat: 11am – 11pm; Sun: 11am – 10pm
Lease or Ownership:	Leased until October 2024
Basset Certification:	Yes – Jeanine Judge
Establishment Violations:	Yes - Dec. 2002 and July 2010 by previous owner
Applicant Liquor Violations:	No

Brinker Restaurant Corporation is the new owner of the existing Chili's Grill & Bar at 640 E. Rand Road. On November 7, 2019 the Arlington Heights Police Department completed background checks on Mr. Christopher Green (President, Secretary) and Mr. Daniel Fuller (Vice President, Treasurer and Assistant Secretary). No issues were noted. On September 11, 2019 the Police Department completed a background check on Jeanine Judge. Ms. Judge is the local Chili's Manager. No issues noted.

A walk-thru of the restaurant was conducted on November 19. The submitted floor plan was adjusted slightly to reflect the actual number of seats.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "AA" liquor license to Brinker Restaurant Corporation dba Chili Grill & Bar upon surrender of the current license issued to that location.
