Special Use for a Restaurant

George Vassos said he hoped to open an Aurelio's Pizza franchise. He said Aurelio's has operated since 1959 with outlets primarily on the south side of Chicago. Trustee Glasgow asked Mr. Vassos to explain the parking situation. Mr. Vassos said the landlord has agreed to add parking spaces in the rear of the building. Mr. Perkins confirmed that the landlord had submitted a permit to add 36 spaces. There had been concern that staff parking would be too near the Starbuck's drive thru and garbage area and that it was insufficient. The property will now have a surplus of spaces. Mr. Vassos said he agreed to all the terms and conditions set forth by staff and the Plan Commission. Trustee Glasgow said he was glad a restaurant was coming to this site. He said it will not be detrimental to the health, safety or morals of the area. Mr. Vassos said he has not yet applied for a liquor license.

Trustee Scaletta agreed that this is a great location for a restaurant as there are a lot of businesses in area and the new apartment tower is now open. He said he was pleased to see a different direction with parking as a lineup of vehicles from the drive thru lane would have created a big problem.

Trustee Blackwood asked if asked if the permit application for additional parking spaces required water detention calculations. Mr. Perkins said that detention calculations must be submitted for the additional 36 impervious spaces.

President Hayes said the Rotary sponsored Santa Run is Saturday, December 6 at 10:00 am.

Trustee Glasgow thanked Community Relations Coordinator Nancy Kluz for making the Village website more accessible. Recently, a language translation option was added. This update was accomplished within the previous budget and addressed the Board's goal of improving communication. He noted that Village Board packet materials are also available on the website so residents can see the materials at home.

President Hayes thanked the Special Events Commission for their efforts planning and executing the annual Holiday Tree Lighting.

#### **XVI. REPORT OF THE VILLAGE MANAGER**

Mr. Recklaus said he had the honor of attending the swearing in of the Village's newest Police Officer Mr. Jeffrey Fontana.

Trustee Glasgow said some misrepresentations were made in a Chicago Tribune article regarding the Village's tax levy. The article headline indicated that the Village was spending a year's worth of revenue in eight months. Mr. Recklaus explained that the Village is transitioning from a May 1/April 30 budget year to a January 1/December 31 budget year. As a result of this change, the fiscal year being adopted for 2015 is eight months long. The expenses, for the most part, are the same. The contributions to the Capital Fund and Reserve Fund occur disproportionately in the 8 month time frame. Mr. Kuehne added that the debt service is unchanged from a 12 month year as the principle interest is also paid in the 8 month period. Mr. Recklaus said the expenses do go down somewhat but not proportionally so.
