SUBJECT: **RESCHEDULED** Liquor License Interview: J&D Mowa, Inc. dba Mowa located at 4216 N. Arlington Heights Road.

At the Committee-of-the-Whole meeting on November 18, a representative from J&D Mowa, Inc. dba Mowa located at 4216 N. Arlington Heights Road will be interviewed for consideration of a full-service "Class "A" liquor license to this establishment.

This is a **rescheduled interview**, as the representative did not attend the November 4 meeting due to his mistake with the date.

Liquor Classification:	Class "A" license permits the retail sale, in restaurants only, of alcoholic liquor for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Mon - Thur: 5pm – 12am; Fri & Sat: 5pm – 1am; Sun: closed
Lease or Ownership:	Leased through 2024
Basset Certification:	Yes
Address Violations:	No
Applicant Liquor Sales Related Violations:	Yes. February 7, 2019 Dong Kim had a Sale of Alcohol to a Minor.

In October 2019, the Arlington Heights Police Department completed a background check on Dong H. Kim. Mr. Kim has 100% ownership interest in the business entity. Through the background check, liquor violations were found that had not been disclosed on the application.

On February 7, 2019, while working at his father's restaurant (San Korean), the Arlington Heights Police Department issued Mr. Kim two local ordinance citations for Sale of Alcohol to a Minor and Failure to Provide Proof of Basset Training. The failure to provide proof of Basset Training was dismissed but the sale to a minor resulted in a guilty finding. Mr. Kim has explained that the reason for the information not being disclosed on his application was unintentional on his part as he was following his father's original application as a template. Mr. Kim stated that omitting the information was an oversight and he did not intend to keep the information off his application. Mr. Kim is now Basset certified.

A walk-thru of the restaurant was conducted on 10/29/19 and the layout is consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to J&D Mowa, Inc. dba Mowa located at 4216 N. Arlington Heights Road.
