SUBJECT: Liquor License Interview: D&J Seoul dba San Korean Cuisine, located at 234 E. Golf Road (International Plaza)

At the Committee-of-the-Whole meeting on November 6, 2017, representatives of D&J Seoul dba San Korean Cuisine located at 234 E. Golf Road will be interviewed for consideration of a beer and wine only "Class "E" liquor license.

Liquor Classification:	Class "E" license permits the retail sale, in restaurants only, of beer and wine for consumption on the premises where sold and has a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Mon - Wed: 11 AM – 10 PM; Thur - Sat: 11 AM - 12 PM; Sun- closed
Lease or Ownership:	Leased until 2022
Basset Certification:	Yes
Establishment Violations:	none
Applicant Liquor Sales Related Violations:	none

On October 9, 2017 the Arlington Heights Police Department completed a background check on Byoung Jin Kim. Mr. Kim has 100% ownership interest in the business entity. No convictions were disclosed and no criminal derogatory information was found. In addition, no lawsuits, judgments, or liens were outstanding.

Mr. Kim has previously held a liquor license in Hoffman Estates and Houston Texas. No liquor related issues were presented.

A walk-thru of the restaurant was conducted on October 30. No issues were noted and the layout was consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "E" liquor license to D&J Seoul dba San Korean Cuisine located at 234 E. Golf Road.
