SUBJECT: Liquor License Interview: Shiya Wine & Spirits, Inc. dba Lyons
Beverage Depot, 135 S. Arlington Heights Road

At the October 18, 2021, Committee of the Whole meeting, the owner of Lyon's Beverage Depot, Shashir Patel, will be interviewed for a Class B liquor license. This is an ownership change for the current location of Cardinal Liquors, 135 S. Arlington Heights Road.

Liquor Classification:	Class "B" license permits the package retail sale of full alcoholic liquor but not for consumption on the premises where sold.
Establishment Liquor Hours:	Monday – Thursday 8:00 am - midnight Friday and Saturday 8:00 am - 1:00 am Sunday 8:00 am - midnight
Lease or Ownership:	Leased thru 5-31-2031
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None

In October, the Arlington Heights Police Department completed a background check on owner Shashir Patel. The following issues were noted:

- 1) The Chicago Police Department arrested the applicant on April 16, 2020 for DUI. The applicant stated he entered a guilty plea, completed court ordered DUI classes and is currently serving two years of probation.

The applicant owns two stores in Chicago that hold liquor licenses and the issues below were related to the Chicago liquor stores:

- 2) Chicago Police officers performed a surprised inspection in 2019. The store was found to be in violation of their liquor license by not having an armed security guard as required. The applicant appealed to change the requirement, which was granted.
- 3) In 2018, an employee sold liquor to an underage customer that was working with the Chicago Police Department. The applicant explained the employee was new and it was a busy weekend. Applicant paid \$1,000 fine.
- 4) In 2018, Officers with the Chicago Police Department located a subject selling individual cigarettes in the parking lot of liquor store. Applicant was reported to be in violation of a section of his liquor license requiring him to call the Police to report subjects loitering. This incident was only documented, no fine or punishment issued.

A walk-thru of the establishment was conducted on October 13, 2021. The store layout was consistent with the floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "B" liquor license to Shiya Wine & Spirits, Inc. dba Lyons Beverage Depot at 135 S. Arlington Heights Road, upon surrender of current license issued to this address.
