APPROVAL OF MINUTES

COMMISSIONER JOSHI MADE A MOTION, SECONDED BY COMMISSIONER SEITZ-PAGANO, TO APPROVE THE MINUTES FROM THE APRIL 6, 2022 ARTS COMMISSION MEETING. ALL WERE IN FAVOR. THE MOTION CARRIED.

MURAL – KENSINGTON ROAD UNDERPASS

Arts Chair Schurtz asked if there is any update regarding the mural project. Staff Liaison Derek Mach provided an update. The Commission discussed August 8, 10 and 15th as potential dates for the dedication. Commissioner Walter commented that barricades might be needed due to the number of bicycles and pedestrian traffic. Commissioner Walter suggested asking the Mayor to distribute a 'certificate of recognition' for each artist. Commissioner Walter also suggested having a program that features each artist. The Commission agreed. Arts Chair Schurtz suggested that the Commission finalize any remaining details at the August 3 Arts Commission meeting.

ARTS OUTREACH EVENT

Staff Liaison Derek Mach explained that in 2019 the Commission was exploring options for an Ikebana outreach event. Commissioner Joshi provided a brief overview and commented that she will begin to explore options again for an event. The Commission discussed that there should be another member as part of a subcommittee to assist with planning the event.

ART SCAVENGER HUNT

Commissioner Souter commented that the library is now hosting a program that is very similar to the Commission's concept. The Commission discussed ideas to modify the program. Staff Liaison Derek Mach explained that a local artist reached with an idea for an art program.

The Commission discussed having an art competition that highlights diversity in Arlington Heights. Commissioner Joshi suggested 'Discovering Arts in Arlington Heights'. Commissioner Joshi commented that the program could include the local businesses. Commissioner Joshi commented that possibly some of the business would be interested in sponsoring some of the artists. Commissioner Souter commented that the program could be a similar arrangement that was utilized for the trains as part of the 125th celebration. Arts Chair Schurtz suggested that the commission continue to discuss details at the August meeting for 'Discovering Arts in Arlington Heights'.
