Village of Arlington Heights Youth Commission Meeting Minutes

August 18, 2014

I. CALL TO ORDER

The regular meeting of the Arlington Heights Youth Commission was called to order by Chair Dyer at 6:08pm in the Commissions Room at Village Hall.

III. APPROVAL OF THE MINUTES

A motion was made by Commissioner Robinson to approve the May 19, 2014 minutes, seconded by Commissioner Guerra. Motion passed by unanimous consent.

IV. REPORTS

Police Department – Commander Hayes stated that there were five arrests for underage consumption which is down from previous years. Peer Jury does not meet in the summer and resumes on September 3, 2014. There are currently 31 members on Peer Jury made up of high school students. Officer Robert Kostka handles liquor compliance and tobacco compliance checks. Commissioner Hayes said they utilize 15-16 year old members of the community who are in good character to assist the Police Department. This is a part time job on an on call basis that pays \$12 per hour. He asked if anyone was interested to contact Officer Kostka or Commissioner Hayes.

Park District – Commissioner Robinson stated that two pools closed and the others will be open through Labor Day. Construction is still underway at Camelot Park – Grand Opening is scheduled for October 11, 2014.

School District – Chair Dyer said that school starts soon!

Arlington Heights Memorial Library – No report.

V. OLD BUSINESS

Art-ify 55 Gallon Waste Containers – Commissioner Dyer said she attended the “Art-ify 55 Gallon Waste Containers” the first Saturday and part of the second day and said it was a

lot of fun. Commissioner Robinson said 30 total cans were painted and they will rotate them throughout the parks. There are some pictures on the Park District's web site.

VI. NEW BUSINESS

Teen Job Fair – Commissioner Dyer asked the Commissioners to bring their calendars to the next meeting so they can choose a date for the 2015 Teen Job Fair.

VII. OTHER BUSINESS

There were 50 entries in the 8th **Annual Teen Film Fest** sponsored by the AHML, Metropolis Performing Arts, and the Arts Commission.

Commissioner Turchik stated that Buffalo Park District had 2 Disc Golf areas and he thought that would be good for Arlington Heights. Commissioner Robinson told the group that the Arlington Heights Park District (AHPD) has looked into constructing a Disc/Frisbee Golf course at Kingsbridge Arboretum Park. He wasn't certain of the date. He also mentioned that in 2015, the AHPD will be offering Foot Golf at Nickol Knoll Golf Course on select days.

Mr. McCalister shared with the Commission that an amendment was made to our Clean Indoor Air Ordinance that requires e-cigarettes be treated the same as cigarettes in the Village of Arlington Heights.

The Commissioners discussed meeting dates in the future and decided to meet the second Thursday of each month at 6:00pm.
