SUBJECT: Liquor License Interview: Sushi De Tapas, Inc dba Kaido Sushi located at 45 W. Golf Road

At the September 18, 2023, Committee of the Whole meeting, Yunsuk Song, the owner of Kaido Sushi, will be interviewed for a Class A liquor license.

Liquor Classification:	Class "A" authorizes the retail sale in restaurants and brew pubs of alcoholic beverages for consumption on the premises. A seating capacity at tables for a minimum of 25 persons for food service is required.
Establishment Liquor Hours:	Monday - Thursday: 4:00 pm to 9:30 pm Friday and Saturday: 4:00 pm to 10:00 pm Closed Sunday
Lease or Ownership:	Leased
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None noted

In July, 2023 the Arlington Heights Police Department completed background checks on owner Yunsuk Song and manager Chun Hwan Park. There were no issues noted.

On September 8, 2023 a walk through was conducted and the submitted floor plan matched what was observed. An additional bench with seats was noted bringing the total seating available up from 28 to 32.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to Sushi De Tapas, Inc dba Kaido Sushi located at 45 W. Golf Road.
