At the Committee-of-the-Whole meeting on August 20, 2018 representatives from Arlington OTB Corp., dba Trackside Arlington Park located at 2000 W. Euclid Avenue will be interviewed for consideration of a full service "Class A" liquor license.

Liquor Classification:	Class "A" license permits the retail sale, in restaurants only, of alcoholic liquor for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Sunday through Wednesday: 11:00 AM - 9:00 PM Thurs.: 11:00 AM – 10:00 PM Fri.: 11:00 AM – 11:00 PM Sat.: 10:00 AM – 11:00 PM
Lease or Ownership:	Owned
Basset Certification:	Yes, On-site Manager Matt Decancq
Establishment Violations:	None
Owner Liquor related Violations:	None

On August 1, 2018, the Arlington Heights Police Department completed a background check on James Stumpf, President of Arlington OTB Corporation. No concerns were noted. On July 16, 2018, the Arlington Heights Police Department completed a background check on Matthew Decancq. No concerns were noted. Mr. Decancq is the on-site manager for the restaurant.

A walk-thru of the establishment was conducted on August 15. No issues were noted. Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" Liquor License to Arlington OTB Corp., dba Trackside Arlington Park.
