**I. CALL TO ORDER**

The regular meeting of the Arlington Heights Youth Commission was called to order by Chair Spicer at 6:09pm in the Commissions Room at Village Hall.

**IV. REPORTS**

**Park District** – No Report

**School District** – Chair Dyer stated that the Thomas Middle School Garage Sale was June, 24<sup>th</sup> at 7:00am.

**Arlington Heights Memorial Library** – Chair Spicer shared that the Library is hosting a Fan Con, which is a pop culture convention on Saturday, June 18<sup>th</sup> with 500+ people signed up to attend.

**Police Department** – Officer Hamrick told the Commissioners that the Whipper Snapper Triathlon will be held at Olympic Park on Saturday, June 18<sup>th</sup>. Befriend a Badge Officers will be there to sign cards as well as Picnic in the Park on June 26<sup>th</sup>. The Police Department is getting ready for Frontier Days also. He mentioned that National Night Out is August 2<sup>nd</sup> at North School Park.

**V. OLD BUSINESS**

**Follow-up with 2016 Teen Job Fair Businesses** – Chair Spicer said that John Robinson contacted all the businesses and thanked them. He did not receive a good response on the

survey that the businesses were asked to take, but he will follow-up. Commissioner Moore asked if the survey was paper or an online survey and stated that people are more prone to respond to the survey if they can just click on a link rather than fill out a paper survey. Chair Spicer said he will ask Commissioner Robinson about the survey.

**Develop 2017 Summer Teen Outdoor Movie** – The Commissioners talked about holding the movie in North School Park or Harmony Park and thought there was more room and parking at North School Park. Chair Spicer thought the planning should be after the Teen Job Fair. They spoke about having Food Trucks that would attract teens to the movie.

**Updates on Replacement Commissioners** – Chair Spicer said that with 3 seniors that graduated, they need new Youth Commissioners. Amalia from St. Viator stated that she will send a letter to Mayor Hayes.

**Volunteering for Frontier Days** – After discussion, the Youth Commission decided to volunteer at Frontier Days on Saturday, July 2<sup>nd</sup> instead of having a meeting. Commissioner Healy had emailed Chair Spicer with a volunteer contact.

**Social Media Accounts for Youth Commission** – Mr. McCalister told the Commissioners that there is a Village Facebook page and Village Twitter account. Nancy Kluz, Community Relations Coordinator, said that if there is anything the Youth Commission wants to post on social media, just send the information to her cell number. Chair Spicer said that one of the Business Librarians can offer training to the Youth Commission on social media at the August meeting. They talked about using/creating an Instagram account and decided against it.

Chair Spicer asked if the Youth Commission meetings can be held at the Library in the future. He feels that the Library has so many resources that the Commission can use and if it is allowable, he would like to move the future meeting to the Library. All Commissioners were in agreement.
