SUBJECT: Liquor License Interview: Egg Harbor Café III, Inc. dba Egg Harbor Café located at 140 E. Wing Street

At the August 2, 2021, Committee of the Whole meeting, two of the owners of Egg Harbor Café at 140 E. Wing Street will be interviewed for a Class A liquor license. This is a new liquor license for this establishment.

Liquor Classification:	Class "A" license permits the retail sale, in restaurants only, of alcoholic liquor for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Monday – Saturday: 8am – 3pm Sunday: 11am – 3pm
Lease or Ownership:	Leased thru 3/23/2027
Basset Certification:	Yes
Address Violations:	No
Applicant Liquor Sales Related Violations:	None

In July, the Arlington Heights Police Department completed background checks on co-owners Aimee Farrell, Michael Farrell and John E. Wright, no issues were noted.

A walk-thru of the establishment was conducted on July 23, 2021. The submitted floor plan was slightly modified to reflect the current seating arrangements.
