SUBJECT: Liquor License Interview: Blitz Sports Bar and BBQ located at 286 West Rand Road

At the August 1, 2022 Committee of the Whole meeting, the owner of Blitz Sports Bar and BBQ, LLC dba Blitz Sports Bar and BBQ located at 286 W. Rand Road will be interviewed for issuance of a liquor license. This is the former JD's Q and Brew location.

Liquor Classification:	Class "AA" license authorizes the retail sale, in restaurants and brew pubs only, of alcoholic liquor for consumption on the premises where sold. Seating at tables for a minimum of 75 persons with full and complete meals.
Establishment Liquor Hours:	Monday and Tuesday 11:00 am – midnight Wednesday and Thursday 11:00 am to 1:00 am Friday and Saturday 11:00 am to 2:00 am Sunday 11:00 am – 1:00 am
Lease or Ownership:	Leased thru November 30, 2027
Basset Certification:	Yes
Address Violations:	July 2011 and June 2012
Applicant Liquor Sales Related Violations:	None

In July 2022, the Arlington Heights Police Department completed a background check on the owner Adalberto Huerta. No issues were noted.

A walk-thru of the establishment was conducted on July 20, 2022. The restaurant layout was consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "AA" liquor license to Blitz Sports Bar and BBQ, LLC dba Blitz Sports Bar and BBQ at 286 W. Rand Road.
