SUBJECT: Liquor License Interview: Ma Jagat Ambe, Inc. dba D & D Smoke & Spirits, 1405 E. Palatine Road, Arlington Heights, IL 60004

At the July 21, 2021, Committee of the Whole meeting, the co-owners of D & D Smoke & Spirits located at 1405 E. Palatine Road will be interviewed for a Class "B" & "T" liquor license. This is a request for a liquor license at a new location.

Liquor Classification:	Class "B" license permits the package retail sale of full alcoholic liquor but not for consumption on the premises where sold. A Class "T" license shall permit the bona fide tasting of alcoholic liquor in its original package to holders of a Class "T" license.
Establishment Liquor Hours:	Sunday - Thursday: 9am-10pm Friday and Saturday: 9am - midnight
Lease or Ownership:	Leased thru 08-01-2026
Basset Certification:	Yes
Address Violations:	No
Applicant Liquor Sales Related Violations:	None

In July, the Arlington Heights Police Department completed background checks on co-owners Pravinkumar (Pravin) Patel and Bhupendrakumar (Bob) Patel who will also be the onsite managers. No issues were noted.

A walk-thru of the establishment was conducted on July 12, 2021. The store was not built out so prior to opening an additional walk through will be conducted to ensure the layout is consistent with the submitted plan.

Upon a satisfactory liquor interview and confirmation of floor plan, it would be appropriate to approve the issuance of a Class "B" and Class "T" liquor license to Ma Jagat Ambe, Inc. dba D & D Smoke & Spirits located at 1405 E. Palatine Rd.
