Background

The purpose of this public hearing is to receive final comments on the proposed:

- 1) Draft 2024 Annual Action Plan including the Community Development Block Grant (CDBG) budget for program year October 1, 2024 – 2025; and
- 2) Draft Substantial Amendments to the 2020-2024 Consolidated Plan.

Subjects of Public Hearing

1. 2024 Annual Action Plan including the CDBG Budget

The 2024 Annual Action Plan states how the Village will address its community development need, especially those of its low- and moderate-income residents, during the October 1, 2024 – September 30, 2025 program year including how the Village will use its available CDBG funds.

The draft of the 2024 Annual Action Plan is provided as Exhibit A. The draft has been updated to include information from the public participation process that has occurred to-date including any public comments received during 30-day the public comment period. The 2024 Annual Action Plan will require a final update to reflect public comments and discussions at the Village Board meeting on July 15, 2024 prior to submission to HUD.

Since the annual CDBG budget has historically been of particular interest to members of the community, the draft 2024 CDBG allocations are provided as a separate exhibit for the convenience of the Village Board and the public. See Exhibit B.

2. 2020-2024 Consolidated Plan Substantial Amendments

This public hearing is also being held to discuss proposed amendments to the 2020-2024 Consolidated Plan. When the 2020-2024 Consolidated Plan was

adopted, the possibility was envisioned that the Village might use \$100,000 of its CDBG funding for an economic development project and \$25,000 for a rental unit preservation project during the 5-year Consolidate Plan period.

The high priority activities of affordable rental housing and economic development were addressed during the 5-year Consolidated Plan period using resources other than CDBG funds. A copy of the sections of the 2020-2024 Consolidated Plan with proposed amendment is provided at Exhibit C.

Executive Summary

1. Introduction

The 2024 Annual Action Plan includes the actions the Village of Arlington Heights will take during the October 1, 2024 – September 30, 2025 program year to address housing and community development needs in the Village of Arlington Heights, particularly the needs of the Village's extremely low-, low-, and moderate-income residents. The 2024 Annual Action Plan also contains the Village's plans for using its Federal Community Development Block Grant (CDBG) allocations during the program year.

The total estimated available revenue for the 2024 program year is \$342,388. The maximum amount that may be spent on public services is estimated at \$51,300, and the amount expected to be allocated to construction projects is \$222,688. The Village maximum that may be spent on administrative costs is \$68,400.

2. Summarize the objectives and outcomes identified in the Plan

In this program year, the Village will address its goals in the areas of homeowner unit preservation, homelessness, public services, public infrastructure, public facilities, and planning & administration. 3. Evaluation of past performance

The Village of Arlington Heights has been a recipient of Community Development Block Grant (CDBG) since 1974. For 50 years, the Village has addressed housing and community development needs of the Village's low- and moderate-income citizens, and has worked effectively with the U.S. Department of Housing and Urban Development.

Annually, HUD reviews the Village's performance in implementing its Consolidated Plan and the immediate past Annual Action Plan. The last such review was for the program year October 1, 2022 - September 30, 2023. The Village has no outstanding issues resulting from that HUD review or any prior HUD reviews; and in its Year-End Review Letter, HUD stated that the Village of Arlington Heights has the continuing capacity to administer Consolidated-Plan-covered programs.

4. Summary of Citizen Participation Process and consultation process

The Village of Arlington Heights will closely follow its Citizen Participation Plan. The main components of that Plan included:

April 2024: The Village invited and accepted CDBG grant applications for CDBG-eligible activities for inclusion in the 2024 Annual Action Plan for the program year (October 1, 2024 - September 30, 2025)

Public Hearing #1 was held on June 10, 2024

30-day public comment period is scheduled for June 12, 2024 – July 12, 2024 on the draft 2024 Annual Action Plan including the CDBG budget

Public Hearing #2 is scheduled for July 15, 2024

The Village will consult with non-profit agencies through the grant application process. The public hearings and 30-day public comment period will be advertised on the Village website, the local newspaper, and by direct mailing to persons on the CDBG Interested Persons List that is maintained by the Village. The Village will also consult with Village departments including Planning, Health & Human Services & Finance.

Narrative

The Village of Arlington Heights works within its own structure and with other entities to ensure community “Resilience.” Resilience planning and activities concerning emergency management is coordinated by the Arlington Heights Fire Department which hold the Village’s Emergency Management Agency responsibilities; oversees emergency/disaster planning; and works closely with other local, state and federal authorities to be informed and prepared concerning matters of homeland security.

In a disaster situation, the Village can access county and state resources and may be eligible for federal assistance. Emergency Management, as it exists today, emphasizes the need for a coordinated effort between all agencies as well as volunteer organizations and private businesses in the community, working together toward a common goal. That goal is to make Arlington Heights as prepared as possible to deal with the effects

of natural, man-made, or technological emergencies or disasters. EMA are locally funded and work under the direction of the Federal Emergency Management Agency (FEMA) through their state government. These disasters include natural disasters such as those caused by weather or other disasters such as the Covid19 pandemic. Information related to planning and response are available on the Village's website.

The Public Works Department maintains all municipally owned property, streets, sidewalks, trees and landscaping, water and sewer systems, buildings and grounds, street lights, and traffic signals. The department also provides other necessities of suburban life such as street sweeping, and snow removal and ice control to provide a safe environment for the Village's residents.

The Village of Arlington Heights Water Utility is proud to provide high-quality drinking water that is clean and safe. The water supplied by the Village complies with all U.S. Environmental Protection Agency (USEPA) standards, including those for lead. There is no adverse situation currently affecting the quality of the Village's water supply.

Beginning in 1985, the Village changed from a deep well ground water source to Lake Michigan surface water. The City of Evanston provides complete water treatment and filtration of all water supplied to Village of Arlington Heights municipal water customers. The Evanston plant adds fluoride and chlorine to the water in accordance with State and Federal guidelines. Additionally, the Evanston plant adds poly orthophosphate as a corrosion inhibitor to guard against lead and copper contamination of the drinking water supply. The Northwest Water Commission (NWC) receives water from the Evanston plant and distributes the water to the four NWC member communities, which includes Arlington Heights.

Arlington Heights' commitment to being a sustainable community is demonstrated through its development of programs that ensure the preservation of resources for future generations. Past endeavors have included a wide array of projects that have proven both cost effective and successful. These projects, coupled with an ongoing effort to seek out new programs that promote sustainability, have established the Village of Arlington Heights at the forefront of the sustainability movement.

Past years have seen the completion of projects that included the replacement of High Pressure Sodium Fixtures to Light Emitting Diode (LED) street lighting, LED traffic signals, parking garage deck lighting, a small solar power producing building, the installation of solar powered warning sirens and multiple recycling programs. In our Water and Sewer pump facilities alone, Water Production staff has retrofitted a total of 19 pump houses, rooms, pipe galleries or wet-well pits with energy efficient LED light fixtures.

CDBG funds may also leverage other government funding from other federally funded programs such as the HOME program, State programs such as those administered by Cook County and the Illinois Housing Development Authority (IHDA), other public housing funds, or funding from other public or private entities. The CDBG entitlement program has no matching requirements.

If appropriate, describe publicly owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

At this time, the Village has not identified any publicly owned land or property located within the jurisdiction that may be used for address the needs identified in the plan.

Discussion

The Village's only source of entitlement funds is the Community Development Block Grant program from which the 2024 entitlement allocation is estimated to be \$300,000. The Village is not required to provide matching funds but does implement programs that support housing and community development needs within the Village. These include the production of housing through the Inclusionary Housing Ordinance which also provides income into the Village's Affordable Housing Trust Fund, the Village's Emergency Assistance Fund, and other programs through the Department of Health and Human Services.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The Village recognizes a strong need for public services among its residents; and therefore, the Village funds numerous public service agencies under its Public Services project. The Village has offered a homeowner unit preservation program since 1978 and applications continue to be submitted for emergency and other important renovation needs to enable low/moderate income residents to remain in their homes. Public facilities has been found to be a strong area of need, and the Village has provided funds to stabilize and improve Village-owned and non-profit owned public facilities such as the Arlington Heights Senior Center and group homes. Public infrastructure is priority of the Village and the Village has been systematically addressing the street resurfacing needs in low/moderate income areas. It is necessary to fund the Village's CDBG administrative costs in order to administer all of the other projects. Requests for CDBG grants always greatly exceed available funds. The Village's relatively low CDBG entitlement grant and lack of other available resources are obstacles to addressing underserved needs.

Rationale for the priorities for allocating investments geographically

Residents in need of affordable housing and public services live throughout the Village. Geographic targeting will take place with respect to infrastructure improvements which will occur in CDBG-eligible low/moderate-income Census Block Groups as limited under the CDBG regulations or will be improvements that remove architectural barriers. In order to support a full range of services, projects and services are sometimes funded at locations outside the Village of Arlington Heights. Some funded agencies' service sites are located a short distance outside of the Village boundaries but are located in adjacent or nearby municipalities. It would be inefficient for the agencies to maintain offices and service centers in in every municipality in their service areas.

Discussion

The Village of Arlington Heights will not direct funds to target areas other than infrastructure projects.

AP-75 Barriers to affordable housing -91.420, 91.220(j)

Introduction

A primary barrier to affordable housing is the cost of land and construction. In the coming year, the Village will continue to implement its affordable Inclusionary Housing Ordinance which requires the inclusion of affordable units in most new multi-family housing developments. The Village will also continue its process for identifying how it will use the funds in its Affordable Housing Trust Fund.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The Village of Arlington Heights has been very proactive in addressing affordable housing needs. The Village regularly reviews its land use controls, tax policies affecting land, zoning ordinance, building codes, fees and charges, growth limitation, and policies affecting residential return on investment. The Village expanded its public policies by adopted an Inclusionary Affordable Housing Ordinance (8/3/2020) to require the creation of affordable units in private housing or collect fees in lieu of affordable units into an Affordable Housing Trust fund for the creation and preservation of affordable housing.

The Village's Housing Commission was created to expand the amount of affordable housing in the Village. The Village's Building Department is proactive in working with owners of rental housing to ensure that the rental housing stock is well maintained. Many non-profit agencies in the Village also work to remove barriers to affordable housing by providing financial assistance, housing counseling, landlord-tenant counseling, and information on other housing related issues.

Discussion

The Village of Arlington Heights focuses directly on addressing barriers to affordable housing. The Village Board has nine strategic priorities for 2024/2025. Strategic Priority #9 is to: Seek, maintain, and expand attainable housing within the community.

Arlington Heights is one of only 9 municipalities in Cook County (which contains 150 municipalities) that the Village is aware have inclusionary housing ordinances. This ordinance has resulted in creating the following numbers of rental, affordable housing units: Timber Court Apartment 14 units; Parkview Apartments 41 units; Heart's Place (permanent supportive housing) 18 units; the Residences at Payton Place 9 units; an

Crescent Place 40 units. The following additional units have been approved but are not yet constructed: Arlington 425 16 units; Eastman Apartments 7 units; and Arlington Gateway 30 units. Additionally, approximately \$1 million has been collected into the Arlington Heights Affordable Housing Trust Fund for future affordable housing initiatives.

Fair Housing: The Village of Arlington Heights has included fair housing requirements in its Village Code. The Village's Housing Commission constitutes the Village's Fair Housing Review Board. This offers convenient and local response to resident's fair housing concerns.

One of the ways in which the Village supports fair housing is to expand housing opportunities. Through its inclusionary housing program, the Village mandates the inclusion of affordable housing units in Arlington Heights. The Village seeks to expand home ownership opportunities by offering the ASSIST home buyer program. In April 2024, in recognition of Fair Housing Month, the Village published educational information and links to fair housing workshops on the Village's website.

Staff is available in the Department of Planning and Community Development and Department of Health and Human Services to respond to fair housing concerns and complaints on a case-by-case basis. In 2024, staff worked on one fair housing complaint with the result that the complainant was able to renew her lease which was her goal.

In April 2023, the members of the Cook County Consortium, and several other entitlement communities, reconvened to continue work on a Cook County Regional Affirmatively Furthering Fair Housing (AFFH) Plan. This work was started before the COVID pandemic and was paused due to other urgent priorities and HUD's initial suspension AFFH implementation and pending new rule. Since HUD's February 9, 2023, publication in the Federal Register of the Notice of Proposed Rulemaking (NPRM) entitled "Affirmatively Furthering Fair Housing," the Consortium is now anticipating planning the development of an AFFH Equity Plan when guidelines are published and final rule-making is complete. The Consortium is looking forward to publication of the AFFH Final Rule and will continue to consult with local partners in the planning and development of a required AFFH Equity Plan within the timeframe required by the Final Rule. In the interim, all Consortium members are utilizing previous Analysis of Impediments and draft AFFH concepts to inform their advancement of fair housing in communities.

AP-85 Other Actions - 91.420, 91.220(k)

Introduction

Below are other actions the Village intends to take during the program year. Other actions are taken by the Village through various Village departments to address community development needs of the Village including the needs of the community's low- and moderate-income residents. Examples include but are not limited to life and safety needs through the Fire and Police Departments; housing safety through the Department of Building and Life Safety; individual and household needs through the Department of Health and Human Services including the operation of the Senior Center; and affordable housing needs through the Department of Planning & Community Development.

Actions planned to address obstacles to meeting underserved needs

The primary obstacle to addressing underserved needs is insufficient funding. The Village will seek funding from other sources and will support service providers in seeking funding from other sources.

Internet Broadband Access: The percentage of household with broadband internet access in the Village of Arlington Heights as reported in the Census American Community Survey 5-year estimate for 2015-2019 is 91.3%. This is a higher percentage than the U.S. overall, Cook County, and the Chicago Region. There are numerous internet service providers offering services to Arlington Heights residents including but not limited to Xfinity, AT&T, Earthlink, Verizon, WOW, Astound, Rise, Viastat, T 5G Home Internet, and e-vertgent. There is sufficient internet service competition. Low-income residents to avail themselves of internet access Affordable Connectivity Program | Federal Communications Commission (fcc.gov) although as of April 2024 this program was paused pending additional funding approval. State assistance is available through <https://www.citizensutilityboard.org/income-qualified-internet-programs/> (Citizens Utility Board website). The Village's Continuity of Services Plan provides priorities, contacts, and steps for maintaining and restoring communication between Village departments including to public safety vehicles.

Actions planned to foster and maintain affordable housing

During the program year, the Village will take the following actions to foster and maintain affordable housing, to remove barriers to affordable housing, and to encourage public housing improvements and resident initiatives:

Professionals in the Department of Planning and Community Development will continue to research and investigate alternative sources of funding to replace or supplement State and Federal funds for

housing assistance and other affordable housing programs. The Housing Planner will monitor housing initiatives at these levels through contact with HUD and through professional organizations and planning offices.

The Village will continue to promote and enforce the goals and policies from the Comprehensive Plan relating to preserving the existing housing stock, encouraging a wide variety of housing types within the Village, utilizing good housing redevelopment concepts, maintaining a good housing balance, preventing housing deterioration, and providing housing for the young, single, and elderly.

Code enforcement will continue to uncover unsafe and unsanitary conditions. The Single-Family Rehabilitation Program will be available to income-eligible individuals to improve their properties.

The Village will implement its Affordable Inclusionary Housing Ordinance and work toward creating affordable units in new construction residential projects and/or with fees collected into the Village's Affordable Housing Trust Fund.

The Housing Commission will continue to promote a balanced housing stock including affordable housing for persons with low to moderate incomes.

The Department of Building and Health Services will work throughout the community to assist residents in securing stable, affordable housing and improve housing and living environments.

No units are expected to be lost from the federally assisted housing inventory in Arlington Heights.

Actions planned to reduce lead-based paint hazards

The Village is aware of the health risks, especially to children, that exist in its older homes due to the presence of lead-based paint. The Village will continue to provide information and blood lead-based paint testing services to Village residents. When persons are identified as having elevated blood levels, the appropriate County and State agencies will be notified, and these persons will be referred for appropriate services.

The Village complies with HUD's lead-based paint regulations with respect to the Village's housing rehabilitation programs. The required notifications, lead-hazard testing, and lead hazard treatment protocols are followed.

Actions planned to reduce the number of poverty-level families

The Village will continue to coordinate efforts to assist households with incomes below the poverty line with other agencies providing services to this population. This will take place through the activities of the Village's Health and Human Services Department and by supporting senior service agencies at the Village's Senior Center. The Health and Human Services Department administers an emergency

assistance fund to assist very low- and low-income persons with emergency needs. Village staff coordinate and combine resources with local agencies to address needs of poverty-level families on a case-by-case basis.

Actions planned to develop institutional structure

The Village will continue to address affordable housing and other community needs within the area by coordinating its efforts with private and non-profit agencies and organizations. The Village will also work with regional planning groups such as the Northwest Suburban CDBG Network, the Metropolitan Mayors Caucus, the Chicago Metropolitan Agency for Planning, the Metropolitan Planning Council (MPC), etc.

Actions planned to enhance coordination between public and private housing and social service agencies

The Village will enhance coordination between public and private housing and social service agencies through the citizen participation plan that encourages all interested parties to share in the Consolidated Planning process. The Village will continue to work with non-profit service providers, other private institutions, public housing and assisted housing providers, and community organizations to discuss community needs and opportunities. The Village will also continue to work with and coordinate the provision of services with Elk Grove and Wheeling Townships, Northwest Housing Partnership, and other Northwest Chicago Suburbs.

Discussion

The Village recognizes that enhancing institutional structure provides efficiencies in service that are of benefit to its residents. The various departments of the Village seek to maximize coordination with public and private housing and service providers to meet the needs in the community.

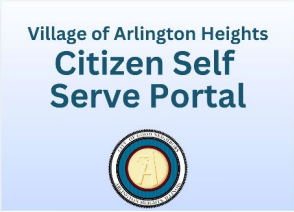

Charles Witherington-Perkins stated this is the first of two public hearings. After tonight the Plan will go to a 30-day public comment period and then there will be a second Public Hearing in July. At that point the Board would take action on adopting the recommendations and we would forward these plans to the approved budget. This particular Plan is the on the Federal Fiscal year cycle which begins October 1st.

Nora Boyer walked through each of the individual requests for the CDBG

Construction Project Requests

The Village consolidates some requests under an umbrella for group-home renovations and administers them through the Housing Commission. Currently this year there is \$115,000 in the group-home renovation program for those projects which are being done by Clearbrook, Little City, Glenkirk and Shelter Inc. For next year, the request for the umbrella group home renovation program is \$170,000. The Housing Commission has also requested renewal of the Single-Family Rehabilitation Program. The Public Infrastructure project is coordinated between the Planning Department and the Engineering Division for street resurfacing in low and moderate-income group areas that are approved by HUD for CDBG funding. The final request is for CDBG Administration which is a capped amount of 20% of the available funds.

Mr. Perkins said one agency from last year did not re-submit this year. The Children at Play (CAP) program was funded last year through the General Fund, not CDBG monies. This allows for staff's recommendations to fully fund and/or increase some funding to the other agencies. The CAP program is a joint agreement between the Village, the Park District and the three elementary school districts to provide before and after school care for children. Originally it was 100% funded from CDBG and then gradually it became 50/50 until last year when it became fully funded from the General Fund.

HUD has asked us to try to increase the amount of grants to agencies and not have so many small ones, so this actually helps us meet and get towards that goal. The CDBG Budget and funding program is not meant to be a social service funding program, it is supposed to be a brick-and-mortar program and so has strict restrictions on the use of CDBG funds for public

service activities. We can only use 15% of the program income on public service activities so that is a maximum of about \$51,300. We increased the construction amounts a little bit because we know construction costs are increasing. There is a higher need in the group homes under single family rehab program this year.

Ms. Boyer explained there is a Five-Year Consolidated Plan and then there are Annual Action Plans under that Five-Year Plan for each of the five years. The proposed substantial amendments would amend the Five-Year Plan which was written in 2019. At that time, there was a possibility of a small rental rehab program and a modest economic development project that could be funded by CDBG funds. These did not end up happening. In addition, the Village received a grant in the CDBG-COVID funds for economic development and in the last few years there's been and the emphasis on inclusionary housing. The rental preservation project did not come forward either. The proposed amendments are to remove that economic development and rental preservation from the Consolidated Plan so it reflects what actually occurred. The second Public Hearing is scheduled for July 15th.

Trustee Tinaglia suggested including the Library in the CAP program. It seems like a natural fit and that they would want to participate.

President Hayes said as far as he knew, the Library had not been asked to participate in the CAP program for programming or funding. The Park District, School Districts and Village have been supporting this program for about the last 30 years. Mr. Perkins agreed saying historically it's been the Park District providing the staff, the schools providing the facilities and the Village providing the funding for the scholarships which this year has jumped significantly, and we anticipate that it could go even higher as District 25 is now providing full year full day kindergarten.

Trustee Tinaglia suggested maybe it would be worth a dialogue with the Library Board because there is a captive audience of young people. Maybe they could find a way to participate, and learn what a wonderful library we have.

Trustee Bertucci thinks it's a good allocation and complimented staff for presenting a good mix and a good blend of all these organizations.

Trustee Grasse asked why Northwest Compass asked for \$30,000 as their request was significantly higher than some of the other agencies' requests (although other agencies asked for more than they received as well). Mr. Perkins said historically they have requested a large amount.

Sonia Ivanov, Executive Director of NW Compass, explained they requested this amount because they are trying to get a 25% match incentive, otherwise they won't even be able to support the housing program that they have. Housing options in the area have increased in price. They provide housing assistance and counseling to families.

President Hayes thanked the agencies for the work they do in assisting Arlington Heights and our community.

Trustee Tinaglia moved to close the Public Hearing. Trustee Schwingbeck seconded the motion. The motion carried unanimously.
