SUBJECT: Liquor License Interview: M and B Alba Corp. dba Barnaby's Family Inn located at 933 W. Rand Rd.

At the Committee-of-the-Whole meeting on July 15, 2019 representatives of M and B Alba Corp. dba Barnaby's Family Inn will be interviewed for consideration of a beer and wine Class "E" liquor license.

Liquor Classification:	Class "E" license permits the sale of beer and wine only for consumption in restaurants that have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Mon - Thurs: 11am - 9pm; Fri - Sat: 11am - 10pm; Sun: 12pm - 9pm
Lease or Ownership:	Leased until July 2024 plus option
Basset Certification:	Yes
Establishment Violations:	Yes Nov. 2002 and Nov. 2009 by previous owner
Applicant Liquor Violations:	Yes Mr. Bernardo Alva in 2001 or 2002

On June 18, 2019 the Arlington Heights Police Department completed background checks on Mr. Mario Alba and Mr. Bernardo Alva. Each applicant has 50% ownership interest in the business entity. No issues were noted.

A walk-thru of the restaurant was conducted on July 8. The submitted floor plan was adjusted slightly to reflect the actual number of seats.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "E" liquor license to M and B Alba Corp. dba Barnaby's Family Inn located at 933 W. Rand Rd upon surrender of the current liquor license issued to this location.
