SUBJECT: Liquor License Interview: Sokol & Leo Inc. dba Fausto's Italian Kitchen located at 16 S. Evergreen Avenue

At the June 20, 2023 Committee of the Whole meeting, the owner of Fausto's Italian Kitchen will be interviewed for a Class E liquor license. This is a current establishment that is adding a liquor license.

Liquor Classification:	Class "E" authorizes the retail sale in restaurants and brew pubs of beer and wine only, for consumption on the premises where sold. A seating capacity at tables for a minimum of 25 persons for food service is required.
Establishment Liquor Hours:	Monday – Sunday: noon to 10:00 pm
Lease or Ownership:	Leased
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None

In May 2023, the Arlington Heights Police Department completed a background check on Leonard Gjoni. No issues were noted.

On June 12, 2023, a walk through was conducted with Leonard Gjoni. At the walk through, it was observed that the room set up reflected the floor plan that had been submitted and a total of 27 seats at tables was observed.

Upon a satisfactory liquor interview it would be appropriate to approve the issuance of a Class "E" liquor license to Sokol & Leo Inc. dba Fausto's Italian Kitchen at 16 S. Evergreen Avenue.
