SUBJECT: Liquor License Interview: Forbici Salon and Spa Ltd. dba Forbici Salon and Spa

At the Committee-of-the-Whole meeting on June 3 representatives of Forbici Salon and Spa, Ltd. dba Forbici Salon and Spa will be interviewed for consideration of a "Class O" liquor license classification for the Salon located at 7 S. Highland Ave. This license allows for beer and wine to be sold at cosmetic facilities.

Liquor Classification:	Class "O" license permits the retail sale of alcoholic liquor for consumption on the premises where sold at cosmetic facilities. Liquor may be sold only to customers of the cosmetic facility during the time they are in the facility to receive services. The retail sale of liquor shall be limited to beer and wine only and no customer shall be served more than two alcoholic beverages during any one calendar day.

The Arlington Heights Police Department completed a background check on Jackie Lewis who has 100% ownership interest in the business entity. No issues were noted.

A walk-thru of the salon was conducted on April 19, 2019. The plan is for wine and beer to be stored inside a locked beverage cooler which is located behind the front reception desk.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "O" liquor license to Forbici Salon and Spa Ltd. dba Forbici Salon and Spa located at 7 S. Highland Ave.
