SUBJECT: Liquor License Interview: Porky's BBQ, Inc dba Porky's BBQ located at 41 S. Dunton Avenue

At the May 15, 2023, Committee of the Whole meeting, the owners of Porky's BBQ will be interviewed for a Class E liquor license. This is a current establishment that is adding a liquor license.

Liquor Classification:	Class "E" authorizes the retail sale in restaurants and brew pubs of beer and wine only, for consumption on the premises where sold. A seating capacity at tables for a minimum of 25 persons for food service is required.
Establishment Liquor Hours:	Wednesday-Saturday: 11:00 am – 8:00 pm Sunday noon – 8:00 pm
Lease or Ownership:	Leased
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None noted

In April, 2023, the Arlington Heights Police Department completed background checks on owners Timothy Vidrio, Carlos Vidrio, Anthony DiJohn and Michael Feuerstein. There were no issues noted.

On May 8, 2023, a walk through was conducted with Timothy Vidrio. At the walk through, it was observed that the room set up did not reflect the floor plan that had been submitted and approved in December 2022 showing the minimum required 25 seats at tables. Mr. Vidrio indicated that they had recently submitted a new floor plan, with a new layout, to the Building Department but, had not submitted the new plan to the Manager's Office. Mr. Vidrio further indicated that the furniture on site was temporary as they are experiencing delivery delays with the permanent furniture. Staff could not verify the set up or floor plan. Another walk through will be needed when the furniture is in place to verify that it complies with the new floor plan and that it includes the minimum 25 seats at tables.

Upon a satisfactory liquor interview it would be appropriate to approve the issuance of a Class "E" liquor license to Porky's BBQ, Inc. dba Porky's BBQ located at 41 S. Dunton Avenue. The liquor license will not be released until the second walk through is satisfactorily completed verifying the floor plan layout and seating minimum is met.
