SUBJECT: Liquor License Interview: Shakou LLC Series Arlington Heights, dba Shakou, located at 70 N. Vail

At the Committee-of-the-Whole meeting on May 15, 2017, representatives of Shakou LLC Series Arlington Heights, dba Shakou, located at 70 N. Vail will be interviewed for consideration of a full service "Class "A" liquor license.

Liquor Classification:	Class "A" license permits the retail sale, in restaurants only, of alcoholic liquor for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Mon - Thurs: 11 AM - Midnight; Fri: 11 AM - 1 AM; Sat: 12 PM - 1 AM; Sun: 4 PM – 10 PM
Lease or Ownership:	Leased until 2027
Basset Certification:	Yes
Establishment Violations:	2002 and 2005 under previous owner
Applicant Liquor Related Sales Violations:	2014 in Libertyville by a bartender

On March 14, 2017 the Arlington Heights Police Department completed a background check on Aleksandar Dupor, and Chrissy Dupor, each owns 50% of Shakou LLC Series Arlington Heights. No convictions were disclosed and no criminal derogatory information was found on either applicant. In addition, no lawsuits, judgments, or liens were outstanding.

Mr. Dupor and Ms. Dupor also own other Shakou Restaurants in Libertyville, St. Charles, Barrington and Park Ridge.

A walk-thru of the restaurant was conducted on May 12. No issues were noted and the layout was updated to reflect the current seating arrangement. This is consistent with the original floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to Shakou LLC Series Arlington Heights, dba Shakou, located at 70 N. Vail.

SUBJECT: Liquor License Interview: Raul's Kitchen Corp., dba Raul's Kitchen
2200 W. Euclid Ave – (Arlington Park Backstretch)

At the Committee-of-the-Whole meeting on May 15, 2017, Mr. Raul Zavala, the owner of Raul's Kitchen Corp., dba Raul's Kitchen, will be interviewed for consideration of a Beer & Wine only "Class "E" liquor license. This restaurant is part of the backstretch area of Arlington Park and has undergone an ownership change since last year.

The Arlington Park Racetrack includes an area called the Backstretch where approximately 1,100 people live during the horse racing season. The entrance to the Backstretch is restricted by security guards. Anyone who works or lives in the Backstretch must be licensed by the Illinois Racing Board. Anyone who visits the area must receive permission and get a visitor's pass. The Backstretch includes a cafeteria or "Backstretch stable kitchen". Mr. Raul Zavala is the contracted vendor to provide food and beverage services for the Backstretch kitchen.

Liquor Classification:	Class "E" license permits the retail sale, in restaurants only, of beer & wine only for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	Mon - Thurs: 8 AM - 9 PM; Fri & Sat: 8 AM - 10 PM; Sun: 11 AM - 10 PM
Lease or Ownership:	Lease: April 12, 2017 – October 2, 2017
Basset Certification:	Yes
Establishment Violations:	Previous Owner in August 2014
Applicant Liquor Related Sales Violations:	None
