SUBJECT: Liquor License Interview: BMAH, Inc. dba Brookhaven Market located at 450 E. Golf Road

At the May 1, 2023, Committee of the Whole meeting, the new owners of Brookhaven Market will be interviewed for a Class B and Class T liquor license. This is the location of the former Value Fresh Market.

Liquor Classification:	Class "B" license permits the retail (package) sale of alcoholic liquor, but not for consumption on the premises sold. A Class "T" license can be combined with a Class B for tasting.
Establishment Liquor Hours:	Sunday-Saturday: 8:00 am – 10:00 pm
Lease or Ownership:	Owned
Basset Certification:	Yes
Address Violations:	February 2005, July 2010, July 2021 and October 2022
Applicant Liquor Sales Related Violations:	None noted

In March, 2023, the Arlington Heights Police Department completed background checks on owners Andreas Eliopoulos, John Manos and John Bertakis as well as store managers John Peter Bertakis and Minos Eliopoulos. There were no issues noted.

On April 19, 2023, a meeting was held with John Manos and store manager Minos Eliopoulos. No issues were noted and no changes were made to the previously approved floor plan.
