I. CALL TO ORDER

The regular meeting of the Arlington Heights Youth Commission was called to order by Chair Spicer at 6:08pm at the Arlington Heights Memorial Library.

III. APPROVAL OF THE MINUTES

A motion was made by Officer Hamrick to approve the January 30, 2017 minutes and seconded by Commissioner Guerra. Motion passed by unanimous consent.

IV. REPORTS

Park District – No Report

School District – No Report

Arlington Heights Memorial Library – Chair Spicer reported that the Science & Technology Fair had a great turn-out with almost 700 teens.

Police Department – Officer Hamrick said that the Police department is working with the Link Together Coalition where teens from 7th grade through 12th grade will clean up a park behind Olive School on Saturday, April 8th.

V. OLD BUSINESS

A. **Planning Movie Night** – The Commission discussed hosting a movie sometime after Frontier Days. Chair Spicer said that if the Commission wanted to promote this in the Library Newsletter, the summer programs are put in one big newsletter every year that covers three months, and the deadline in April 1st. Commissioner Moore suggested putting something in the Library Newsletter “Movie Night for Teens is in the planning stages for July – check the website for more information”. Commissioner Robinson shared that the Park District he works for now hosts five movies per year and when in Arlington Heights they hosted two per year. He said

you can't just show a movie on a screen somewhere, you need to have some sort of licensing in order to show a movie and it averages \$300. You also need to rent a screen. He suggested getting a table at Frontier Days so that Youth Commissioners can hand out flyers for the movie or even the Let it Snow, Make it Go program. After discussion, Commissioner Robinson said he will contact the Park District about dates that will work. They would also like to invite food trucks or an ice cream truck. Chair Spicer asked the Youth Commissioners to check out PG movies they think teens would be interested in seeing. Officer Hamrick asked if the Commission thought they would need Police as the movie would not start until dark and end about 11:00pm. They agreed that Police should be involved.

Commissioner Robinson stated that there are two parade opportunities that the Youth Commission can be involved in to promote the Movie Night and the Let it Snow, Make it Go program. He said they would not need to make a float, but can walk and handout flyers.

Mr. McCalister said the Village owns a popcorn machine that can be used for the Movie Night.

- B. Updates on Let it Snow, Make it Go Program** – Mr. McCalister reported that he didn't know if anyone shoveled after the last snowfall, but there were six teens and three seniors that signed up for the program. They discussed promoting this program next November to get the word out again.
