SUBJECT: Liquor License Interview: Our Southern Kitchen, Inc. dba Southern Kitchen located at 818 E. Kensington

At the April 14, 2022, Committee of the Whole meeting, the owners of Southern Kitchen will be interviewed for a Class A liquor license. This is a new restaurant in the former Eros Restaurant location.

Liquor Classification:	Class "A" license authorizes the retail sale, in restaurants and brew pubs only, of alcoholic liquor for consumption on the premises where sold. Seating at tables for a minimum of 25 persons with full and complete meals.
Establishment Liquor Hours:	Monday – Saturday 8:00 am – 3:00 pm Sunday 11:00 am – 3:00 pm
Lease or Ownership:	Leased thru 10-6-46
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None

In March 2022, the Arlington Heights Police Department completed background checks on owners Frank Geogacopoulos, Steve Fotos and Arry Marwavos. No issues were noted.

A walk-thru of the establishment was conducted on April 13, 2022. The restaurant layout was consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to Our Southern Kitchen, Inc. dba Southern Kitchen located at 818 E. Kensington.
