Resident Melissa Cayer asked for this item to be removed from the Consent Agenda. She asked how much were the fees and questioned why the Park District should have theirs waived. She also wanted to know what the menu was and suggested that the fees could be paid out of profits from the sale of alcohol.

President Hayes said this question has been asked by Ms. Cayer before. Mr. Recklaus said the Park District is required to have a license to serve liquor at the golf courses. As the Park District is also a taxing body, it is not appropriate to tax the tax payer. Any revenue generated by the sale of alcohol offsets property taxes and fees the Park District charges.
