SUBJECT: Liquor License Interview: Marbling, Inc. dba Marbling located at 63 W Golf.

At the April 1, 2024 Committee of the Whole meeting, Kyong A Lim owner of Marbling will be interviewed for a Class A liquor license.

Liquor Classification:	Class A authorizes the retail sale in restaurants and brew pubs of alcoholic beverages for consumption on the premises. A seating capacity at tables for a minimum of 25 persons for food service is required.	
Establishment Liquor Hours:	Tuesday-Sunday	4:00 pm – 11:00 pm
Lease or Ownership:	Leased	
Basset Certification:	Yes	
Address Violations:	No	
Applicant Liquor Sales Related Violations:	No	

In May, 2023 the Arlington Heights Police Department completed a background check on owner Kyong A Lim. There were no issues noted.

In June, 2023, the applicant asked to be put on hold as the building was under the public hearing process. In November, 2023 a walk through was requested but would not be completed as further build out was taking place. The applicant was instructed to contact the Village when the process was completed.

On March 26, 2024 a walk through was conducted. Minor adjustments were made to the submitted floor plan to reflected what was observed on site.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class A liquor license to Marbling, Inc. dba Marbling located at 63 W. Golf.
