At the March 18, 2022, Committee of the Whole meeting, the new owners of Honey-Jam Café will be interviewed for a Class AA Liquor License

Liquor Classification:	Class "AA" license authorizes the retail sale, in restaurants and brew pubs only, of alcoholic liquor for consumption on the premises where sold. Seating at tables for a minimum of 75 persons with full and complete meals.
Establishment Liquor Hours:	Monday – Saturday 8:00 am – 2:30 pm Sunday 10:00 am – 2:30 pm
Lease or Ownership:	Leased thru 1-1-28
Basset Certification:	Yes
Address Violations:	September 2015 and November 2021
Applicant Liquor Sales Related Violations:	None

In March 2022, the Arlington Heights Police Department completed background checks on owners Caroline Brannan and Josh Brannan as well as Manger, Kristina Kummerow. There were no issues noted.

A walk-thru of the establishment was conducted on March 15, 2022. The restaurant layout was consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "AA" liquor license to Honey Jam Café LLC dba Honey-Jam Café located at 2944 W. Euclid Avenue upon the surrender of the existing license issued to that address.
