I. CALL TO ORDER

III. APPROVAL OF THE MINUTES

A motion was made by Commissioner Johnson to approve the January 22, 2015 minutes and seconded by Commissioner Guerra. Motion passed by unanimous consent.

IV. REPORTS

Park District – The Park Board approved two large projects for renovation. Arlington Lakes Golf Course will be shut down June 8, 2015 for one year to update the facility. Heritage Tennis Club will be remodeled inside in the spring of 2016. Commissioner Robinson told the group he was leaving the Arlington Heights Park District to take a job in Western Springs as the Executive Director. He asked Mayor Hayes to stay on the Youth Commission as a resident.

School District – No Report

Arlington Heights Memorial Library – Commissioner Spicer said he was leading a book discussion next week on Boxers & Saints, a companion graphic novel set written by Gene Luen Yang who came to the library a few weeks ago.

Police Department – Commander Hayes reported that the Village of Arlington Heights was voted the 3rd safest city in American for towns with over 75,000 residents.
