located at 286 W. Rand Road.

At the March 4, 2024 Committee of the Whole meeting, Peter Dalamangas owner of Nostimo Greek Kitchen will be interviewed for a Class AA liquor license. This location is the site of the former Blitz Sports Bar and BBQ.

Liquor Classification:	Class "AA" authorizes the retail sale in restaurants and brew pubs of alcoholic beverages for consumption on the premises. A seating capacity at tables for a minimum of 75 persons for food service is required.
Establishment Liquor Hours:	Sunday - Thursday 11:00 am – 11:00 pm
Lease or Ownership:	Leased
Basset Certification:	Yes
Address Violations:	Yes, December 2022 – former owner failed to remove all alcoholic beverages from all service areas, tables, counter bars and other areas within 10 minutes following the end of the business's permissible hours of operation. Fine \$750.00
Applicant Liquor Sales Related Violations:	None noted

In February, 2024, the Arlington Heights Police Department completed a background check on owner Peter Dalamangas. There were no issues noted.

On February 28, 2024, a walk through was conducted. The submitted floor plan reflected what was observed on site.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "AA" liquor license to Nostimo LLC dba Nostimo Geek Kitchen located at 286 W. Rand Road.
