APPROVAL OF MINUTES

MURAL – KENSINGTON ROAD UNDERPASS

PHOTOGRAPHY COMPETITION

The Commission discussed the presentation of the winner of the 2020 photography competition. The Commission discussed that the winner will be recognized at the December 6, 2021 Village Board meeting. Commissioner Higgins-Thrash reminded the Commission that the plan is to take a picture of the winner being recognized and a plaque will be created and shared in order to recognize their achievement.

BANNER PROJECT

Staff Liaison Derek Mach explained that previously the Arts Commission made a motion to recognize the winners of the 2020 Banner Program. The Commission agreed to continue to move forward. Staff Liaison Derek Mach commented that a letter will be put together recognizing the winners.

ARTS OUTREACH EVENT

Staff Liaison Derek Mach explained that in 2019 the Commission was exploring options for an Ikebana event. Commissioner Seitz-Pagano suggested that discussion continue at a future meeting when Commissioner Joshi is present. The Commission agreed. The Commission discussed the tentative timeline for the event in 2023. Commissioner Wolf commented that thought should be given to the timing of the event and the planning involved.

ART AROUND TOWN

Commissioner Higgins-Thrash suggested that the A.R.T. Around Town brochure be postponed and evaluated for 2023. The Commission agreed.

Arts Chair Schurtz asked if there are any public comments. Ms. Cayer commented that the website calendar could be utilized for advertising and promoting art events.

ART SCAVENGER HUNT
