Mr. Recklaus said that after a redevelopment project area is created, a 10 year Status Report and Public Hearing are required. TIF 5 was created in 2005, so now is the appropriate time to review the project.

Mr. Enright said TIF 5's fund balance for fiscal year 2014 is \$1.5 million. There is \$870,000 left in debt payments. A bond was issued to help with the redevelopment of the Town & Country Shopping Mall. This Mall had suffered from vacancies and the closing of the movie theater. A developer came in and redeveloped it and it is now a thriving mall with many retail tenants. The second part of the area is the Southpoint Shopping Center. The new Floor and Decor store is a positive addition. The mall is still suffering from vacancies. Staff is working with various owners of the space. The Village has hired a consultant to conduct a Corridor Beautification study to improve the unity of the uptown shopping district. The TIF is doing well, but there is more to be done.

Trustee Rosenberg asked if there will be sufficient funds to help redevelop Southpoint. Mr. Enright said it depends on what is requested by a developer. He said that the developer would have to prove need, and if the revenue is there, the Village can help. He said it would most likely be a pay-as-you-go scenario, so needs would be met only if the revenue is there.

VIDEO A. Parkview Apartments - 212 N. Dunton Ave. - PC#14- Approved

 Final Planned Unit Development

Trustee Tinaglia recused himself.

Mr. Recklaus said a seven story mixed use building is proposed for 212 N.
Dunton. It includes 45 apartments and internal parking. This project was
approved with conditions at the January 28th Plan Commission meeting.

Mr. Perkins said the Preliminary PUD of this project was approved by the Board with conditions. This Final PUD recommends some additional conditions: the petitioner will pay a fee in lieu of onsite water detention, a hold harmless agreement must be completed for the balconies which project over the public right of way, the seven affordable units shall be maintained as affordable in perpetuity, and the exhaust venting shall be designed so that it does not impact adjacent residents as well as residents of a potential new building or development to the south.

Mr. Michael Ezgur, attorney for the project, said that the petitioner is okay with these additional conditions.

Trustee Labedz asked for an explanation on the affordable apartment time requirements. Mr. Perkins said that the financing through the tax credit program differs from the Village's criteria. The financing requires the apartments to maintain their affordable status for 15-30 years. The Village's provisions extend into perpetuity. Staff thought it wise to include this language in the ordinance for clarity.
