SUBJECT: Liquor License Interview: NEAD Investment Group Corp dba Rokbonki Japanese Steakhouse at 876 W. Dundee Road

At the February 7, 2022 Committee of the Whole meeting, NEAD Investment Group Corp dba Rokbonki Japanese Steakhouse at 876 W. Dundee Rd. will be interviewed for a Class A liquor license. This is a change in ownership.

Liquor Classification:	Class "A" license permits the retail sale in restaurants and brew pubs of alcoholic beverages for consumption on the premises. The restaurant must have a minimum seating capacity at table for 25 people and full and complete meals must be offered.
Establishment Liquor Hours:	Monday – Saturday 10:00 am – midnight Sunday 11:00 am - midnight
Lease or Ownership:	December 31, 2029
Basset Certification:	Yes
Address Violations:	June 2002 July 2021
Applicant Liquor Sales Related Violations:	None

In January, the Arlington Heights Police Department completed a background check on owners Dean Badruddin, Nadirshan Ali, Esmael Ghaziani and Ameen Huda. On-site Manager Munkh-Orgil Shijrbaatr also had a background check completed. There were no issues noted on any of the background checks. A walk-thru of the establishment was conducted on January 26, 2022. The store layout was consistent with the submitted floor plan.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to NEAD Investment Group dba Rokbonki Japanese Steakhouse at 876 W. Dundee, upon surrender of current license issued to this address.
