SUBJECT: Liquor License Interview: AVX Restaurant, Inc. dba Golden Brunch
located at 31 E. Golf Road

At the February 1, 2021 Committee of the Whole meeting, the co-owners of AVX Restaurant, Inc. dba Golden Brunch located at 31 E. Golf Road will be interviewed for a Class A liquor license. This location is the former IHOP Restaurant.

Liquor Classification:	Class "A" license permits the retail sale, in restaurants only, of alcoholic liquor for consumption on the premises where sold and have a seating capacity at tables for a minimum of 25 persons for food service.
Establishment Liquor Hours:	M-F 8am- 2:30 pm, Sat 8 am –3:00 pm, Sunday 11am-3:00 pm
Lease or Ownership:	Leased thru 7-31-27
Basset Certification:	Yes
Address Violations:	None
Applicant Liquor Sales Related Violations:	None

In January, the Arlington Heights Police Department completed background checks on Efstathios Stellatos and Anargyros Karafotias, each having 50% ownership interest in the business entity. No issues were noted.

A walk-thru of the establishment was conducted on January 15. The submitted floor plan reflects the current seating arrangements.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "A" liquor license to AVX Restaurant, Inc dba Golden Brunch located at 31 E. Golf Road.
