SUBJECT: Liquor License Interview: 3435 N. Kennicott LLC dba Arlington Lanes

At the Committee-of-the-Whole meeting on January 22, representatives of 3435 N. Kennicott LLC dba Arlington Lanes will be interviewed for consideration of a "Class DD" liquor license classification for the bowling alley located at 3435 N. Kennicott. This license allows for full service of alcoholic beverages at a bowling alley.

The applicant, Mr. Mark Giannecchini, intends to buy the building and the bowling alley business from the current owner. The scheduled closing date is the end of February.

Liquor Classification:	Class "DD" license permits alcoholic liquor for on-premise consumption at bowling alleys.
Establishment Liquor Hours:	Mon - Thur: 8am – 1am; Fri - Sat: 8am – 2am; Sun: 10am – 1am
Lease or Ownership:	Needs to provide applicable documentation
Basset Certification:	Yes
Address Violations:	Yes, August 2009 by previous ownership
Applicant Liquor Sales Related Violations:	None

In January 2019, the Arlington Heights Police Department completed background checks on Mark Giannecchini and Carol Giannecchini who each have 50% ownership interest in the business entity. No issues were noted.

Upon a satisfactory liquor interview, it would be appropriate to approve the issuance of a Class "DD" liquor license to 3435 N. Kennicott LLC dba Arlington Lanes. Liquor License will be issued upon sufficient proof of meeting all outstanding eligibility requirements as well as surrender of the current liquor license issued to this address.
