I. CALL TO ORDER

Chair Spicer called the regular meeting of the Arlington Heights Youth Commission to order at 6:02pm at the Arlington Heights Memorial Library.

III. APPROVAL OF THE MINUTES

A motion was made by Commissioner Mahon to approve the October 4, 2017 minutes and seconded by Commissioner Lawrence. Motion passed by unanimous consent.

Chair Spicer asked the guests to introduce themselves. Sydney introduced herself as the Adult Program Coordinator at the Library. Alice introduced herself as the Teen Librarian.

IV. REPORTS

Park District – Commissioner Healy shared that the Tree Lighting Ceremony will be Friday, November 24th at North School Park.

School District –

Arlington Heights Memorial Library – Chair Spicer reported that “Finals” study would be in the HUB in December.

Police Department –

Commissioners at Large – The Youth Commissioners gave updates on activities at their schools.

Commissioner Robinson shared that he is on the Frontier Days Festival Committee and Teen Battle of the Bands will be part of Frontier Days in 2018. He will bring more information when available about teens judging this competition.

V. OLD BUSINESS

Teen Snow Shoveling Program, “Let it Snow, Make it Go” – Mr. McCalister explained that currently there are seven teens signed up to shovel and seven seniors signed up looking for help with shoveling. The Senior Center Manager sent letters with the list of teens willing to shovel to those looking for help shoveling.

Chair Spicer shared the Snow Shoveling Flyer and asked the Youth Members to share this with their school to get the word out.

He asked if the Commissioners wanted to create a promotional video in the AHML studio that can be viewed on the Village access channel, social media accounts, and shared at the high schools. They agreed and shared ideas regarding what could be included in the videos and the length of the videos. Commissioner Healy said the informational video and flyer can be posted on the Park District Facebook page.

Teen Movie Night – The Commissioners discussed the movie topics geared at teens including Dodgeball, Star Wars, Avengers, and Dark Night. They talked about reserving the swimming pool at Rec Park for teens only and will discuss this again in the future. There was discussion on having a Teen Band before the movie as well as a Spike Ball tournament.

2018 Teen Job Fair – The Commissioners picked businesses they would contact regarding the Job Fair. The business letters will be available at the December meeting.

Alice will be coordinating a prep prior to the Job Fair called “How to Job Fair” from 5:00pm-6:00pm. Last year there were 35 teens that came early to the HUB for the “mock interviews”, “what to wear”, “eye contact”, “what kind of questions that might be asked of you”, etc.
