APPROVAL OF MINUTES

- Minutes from July 11, 2024. Motion to approve updated minutes was made by Karen DeZellar with a second from Laurie Mitchell.

OLD BUSINESS

- **Autumn Harvest 2024**
Autumn Harvest will take place on Saturday, October 5th, 11 a.m. – 2 p.m. at North School Park. Items needed for scarecrow decorating will be ordered. Clothes are needed. Commissioners will bring items to be used. Messaging will encourage guests to bring their own clothing and décor. A walk-through with Village and Park District staff will take place on 9/16 at 9:45 a.m. Pumpkins will be delivered to Public Works on Friday, 10/4. Sound needs to be given to Public Works for performances. Sponsorship banner will be hung up. Marketing efforts will be ongoing. Posters will be added to Harmony Park after Sounds of Summer.
- **Tree Lighting 2024**
Tree Lighting 2024 will take place on Friday, Nov. 29th, 4:30 – 6:30 p.m., with the tree lighting at 5 p.m. Trolleys have been reserved and reindeers have been hired, including a wheelchair accessible mini-bus. Staff will order 2 angel wing displays and the remaining funds will be used for purchasing light up giveaways for guests. A sponsor sign will be displayed at the 3-D glasses station. Staff will need to order 24 stanchions instead of renting annually. Staff will have neon vests for event, and will borrow from Police for this event and will purchase their own in 2025. Signage will be updated to reflect this year's sponsors and to include "wheelchair accessible vehicle available upon request."
