Transportation Report

Commissioner Feldman on the memo that Liaison Colagrossi drafted for the Senior Citizens Commission and for the Commission for Citizens with Disabilities to review. Liaison Mercado stated that their next meeting would be until November 12. Commissioner Feldman requested that Liaison Mercado review the letter with her commission via blind copy and advise Liaison Colagrossi for feedback before Thursday this week. Ms. Mercado agreed, and Ms. Colagrossi will send the memo to

the Village Manager with additional feedback this week. The memo requests the opportunity for the commissioners to advocate for increased funding for public transportation options on weekends and evenings, as these are not current options for people in the Village of Arlington Heights.

Liaison Colagrossi added that there is a RTA Transit Summit on Thursday, October 24 in Arlington Heights which she and Commissioner Calibraro will attend. The summit purpose is to gather feedback and build support for improved service with new funding.

Housing Report

Commissioner Vogt had nothing to report on the Housing Commission, only that they have expressed the desire to meet with the Senior Citizens Commission. Nora Boyer, City Planner, advised Liaison Colagrossi that they are consulting with the lawyers to ensure that there are no violations of open meetings acts or Roberts Rules of Order for the joint meeting. The meeting most likely will occur in the new year with a clear agenda that both commissions will agree upon.
