I. CALL TO ORDER

The regular meeting of the Arlington Heights Commission for Citizens with Disabilities was called to order by Chairman Ramsey at 7:04 pm in the Buechner Room at Village Hall.

III. APPROVAL OF THE MINUTES

A motion was made by Commissioner McMahon to approve the August 9, 2022 minutes as written, seconded by Commissioner McCallum. Motion passed by unanimous consent.

IV. REPORTS

Coordinator Espinoza reported that the interviewing process for the social work position continues.

V. OLD BUSINESS

A. DISABILITY EMPLOYMENT AWARD

Coordinator Espinoza reported that there were four nominations for the award submitted. The nominees included the U.S. Department of Labor-OSHA Training, Church Creek Senior Living, The Arlington Heights Memorial Library and Mariano's Grocery Store. After distribution of the written nominations, the Commission discussed the different attributes of each of the nominees. A vote was taken among the Commission. Church Creek Senior Living was chosen by unanimous consent to be the recipient of the 2022 Disability Employment Award. The Award will be presented at the Village Board Meeting, Monday, October 17th, 2022. The Commission will be present for the Board Meeting and host a pre-meeting reception to honor Church Creek. Coordinator Espinoza will reach out to Church Creek and notify them of the award they will receive and details involving the presentation. Espinoza will order the actual award and coordinate the reception.

B. DISABILITY TRAINING

Commissioner Calibraro reported that the Special Needs Trust and Future Planning presentation is scheduled with Brian and Benjamin Rubin. The Presentation will take place via Zoom format from Rubin Law on Wednesday, October 19th, 2022. Coordinator Espinoza stated she will continue to work with the Communications Director regarding details regarding announcements, sign up and participation for the Zoom event. Details regarding interpreters and cancelling the scheduled space at the Senior Center were discussed.

C. KNIGHTS OF COLUMBUS

The Commission will again participate in the Knights of Columbus drive, Friday, September 16th and Saturday, September 17th at the North Point Jewel location. Coordinator Espinoza shared the sign-up sheet with volunteers selected time slots.

D. CAPTIONING

Coordinator Espinoza reported that the Village will explore remote closed captioning as automated captioning was cost prohibitive. She reported that Commission feedback was sought to obtain additional information regarding features of each captioning option.
