Chairperson

Subcommittee Chairperson Viecegli inquired as to how many people completed the survey regarding Housing Affordability. Liaison Colagrossi advised that the survey has been available inside the Live Well, Age Well Newsletter and the link will go out on the next e-blast. She added that half page flyers are also available to fill out at

the Senior Center front desk. To start, the collection time is six weeks. If people are slow to respond, the collection time can be extended.

Liaison Report

Liaison Colagrossi reported on the progress of the Senior Center Facebook page. There are 400 followers since the last time the subcommittee met. 81% of followers are women. 190 followers are Arlington Heights residents while the remaining come from surrounding suburbs.

In addition, Liaison Colagrossi reported that the next "Roadshow" event is scheduled for Thursday, July 19 at Lake Arlington. Sixty people have pre-registered for the event to learn how to kayak and have a Kona Ice treat. With the forecast of high degree weather, the expectation of attendees may be lower.

The Live Well, Age Well Expo held at the Senior Cener on June 29 promises to be a large turnout of 250 people preregistered. The next "Roadshow" event following the Lake Arlington site, will be at the Arlington Heights Farmers Market to create a community art project that will be displayed at the Arlington Heights Senior Center. The marketing material brochures have been created and will be translated into five different languages. The Senior Center Foundation will be underwriting \$5,000 of the costs.

Liaison Colagrossi added that she and the Nursing Supervisor presented the Health and Human Services Biennial Report to the Board on May 27 and was well received. The board was interested in the Commission's work in Age-Friendly.
