1. Transportation Report

Commissioner Feldman reported on transportation. The RTA has modified its identification of what consists of the financial or the fiscal cliff. They had initially identified it as an amount of about \$770 million and have since adjusted to \$202 million for fiscal 2026. The \$700 million figure was for 2026 and 2027. If not addressed during the veto session, then during the second year of the session of the 104th General Assembly. The RTA has already proposed fare increases and service cuts.

2. Housing Report

Commissioner Raminiak reported that he and Commissioner Vogt attended the Housing Commission meeting on Wednesday, October 15. The Housing Commission had previously requested the data collected by the Senior Citizens Commission over the summer regarding housing affordability for older adult residents, which was provided to them in September. The Senior Citizens Commission also submitted a memo for the Housing Commission's consideration. However, due to the meeting's focus on reviewing priorities related to the Affordable Housing Trust Fund, the memo was not discussed at that time. The Housing Commission liaison indicated that the memo will be made available for review by commissioners at their next meeting.

Commissioners Raminiak and Vogt plan on attending the next Housing Commission meeting in November.
