III. APPROVAL OF MINUTES

COMMISSIONER FELDMAN REQUESTED A MOTION TO APPROVE THE MINUTES OF MARCH 13, 2026. COMMISSIONER RAMINIAK MADE A MOTION AND WAS SECONDED BY COMMISSIONER VOGT. ALL WERE IN FAVOR AND THE MINUTES OF MARCH 13, 2026, WERE APPROVED.

IV. Reports

A. Transportation Report

No major legislative updates at this time

- Relevant transportation bills (including House Bill 4333 / Waymo-related legislation) remain in the Rules Committee and are unlikely to move forward this session
- Pace On-Demand Service Discussion
 - Positive feedback on recent ribbon cutting event
 - Continued encouragement for community members to utilize the service
 - Identified Service Gaps
- Certain areas of Arlington Heights are not currently served:
 - Cook County Health facility (Arlington Heights Rd. near Dundee)
 - Areas east of Arlington Heights Rd.
 - Area's south of Central Rd.
 - Concern identified as a "transportation desert" impacting access to medical care
- Next Steps
 - Committee members to provide additional feedback on service gaps
 - Feedback will be compiled and shared with Village staff (Maggie Trevor)

B. Housing Affordability Housing Commission Coordination

Representatives (Steve Raminiak and Fred Vogt) attended the Housing Commission meeting

Proposal will be formally discussed at the April 15 Housing Commission meeting

Request to bring forward a formal motion at the Senior Citizens Commission meeting to authorize representation

Proposal Discussion & Feedback

Comparison to Existing Programs

- Village Emergency Assistance Program identified:
 - Provides short-term (up to 18 months) crisis-based assistance
 - Not limited to seniors
- Key distinction:
 - Current proposal focuses on long-term housing stability for seniors aging in place

Glenview Program Research

Two programs identified:

- ANGEL Fund (similar to emergency assistance)
- Senior Housing Assistance Program (limited detail available)

Further research needed, particularly on:

- Intake process
- Funding structure
- Monthly assistance levels

Ordinance Considerations

Concern raised regarding alignment with 2013 Inclusionary Housing Ordinance

Key takeaway:

- Proposal may not align with all subsections

Potential pathway:

- Argue eligibility under allowable subsection, or
- Pursue ordinance amendment

Policy & Role Considerations

Discussion on whether housing assistance should be:

- A local government responsibility, or
- Left to charitable organizations

Consensus:

- Affordable housing is a Village priority
- Proposal supports broader strategic goals

Program Design Considerations

Recommendations for strengthening the proposal:

- Establish time limits (e.g., 2–5 years)
- Consider financial caps on assistance
- Explore creation of a pilot program before full-scale funding

Define:

- Eligibility criteria
- Income thresholds
- Sustainability requirements for participants

Existing Criteria (from draft proposal)

- Age 55+
- Arlington Heights residency (minimum 3 years)
- Extremely low income (AMI-based)
- Demonstrated difficulty affording housing costs
- Not currently receiving subsidized housing

Broader Housing Strategy Discussion

Recognition of dual priorities:

- Aging in place (supporting current residents)
- Increasing affordable housing supply (new units)
- Discussion included:
 - Use of Village-owned land for development
 - Partnerships with developers
 - Inclusionary housing strategies

Advocacy vs. Education

- Clarified role of the Commission:
- Cannot formally advocate policy positions
- Can educate, raise awareness, and facilitate discussion

Procedural Items

Motion needed to:

- Authorize representatives to present to Housing Commission
- Agenda considerations:
 - Must comply with Open Meetings Act (48-hour notice)
 - Likely can be addressed under Old Business, but staff will confirm
