I. Call to Order

II. Approval of Minutes

Commissioner Skrudland moved to approve the minutes of the May 6, 2026, Environmental Commission meeting. Commissioner Wilks seconded the Motion. The Motion passed unanimously.

IV. Old Business

Chair Jordan asked for updates on the Commission projects.

- A. Landfill diversion
Commissioner Eisenhardt wasn't available for an update.
- B. Livestream event
Commissioner Flores stated the event, scheduled for September 12 from 1-3pm, will consist of a panel discussion followed by an interview portion. He has been finalizing who will be speaking in each portion of the event and staffing informational booths.
- C. Publication of Sustainability Metrics
Commissioner Porwit wasn't available for an update.
- D. Curbside Composting Awareness
Commissioner Skrudland said she and Chair Jordan had attended the last two Farmers Markets with flyers and a QR code for the preliminary composting survey to discover barriers to participation in curbside composting. The preliminary survey seemed to be working well. She was making two versions of the survey- one for residents that already participated in the program and a version for everyone else. The surveys would then be available at the market and could be shared via social media.
- E. Recognition Program for Sustainable Businesses

Chair Jordan has an upcoming meeting with the Director of Health Services and Village Economic Development Manager to discuss a possible program.

F. Textile Recycling

Commissioner Wilk presented research he had completed on textile recycling. While the Village doesn't have a program, Mt. Prospect and Palatine have a program for collection of textiles and household goods from residents' doorsteps. The program is through Simple Recycling, which also provides collections in the Village. He noted that, even though residents can contact any collection company or utilize local thrift stores and drop-off locations, the choices are very hard to find. The Village should make the information easier to find on the website and publicize the options better, in his opinion.

G. Polystyrene Reduction

Youth Commissioner Finn distributed a report on polystyrene. Chair Jordan asked all members to read the report and be prepared to discuss at the next meeting.
